### **BUS BEHAVIOR GUIDELINES**

We want to honor God throughout our trip, so we will encourage Godly behavior by:

#### Respecting and Submitting to Authority

- All adults riding on the bus will work as a team with the Bus Captain to help keep morale high and discipline situations at a minimum.
- Leaders' authority is to be respected at all times. The Bus Captain, in consultation with other adult leaders, has final discretion on all matters.

#### **Showing Respect/Honor to One Another**

- Music can be played loud enough for personal listening and should not be distracting to other passengers or the driver.
- Quiet time will be observed between 12:00 am and 7:00 am. Riders may listen to music during quiet hours, but all other electronic devices, including cell phones, are to be turned off. No screen use between the hours of 12:00 am and 5:30 am.

#### A Commitment to Purity

- Only appropriate videos will be shown on the bus DVD player. Students/adults may bring DVDs with a G or PG rating. The bus captain will use his/her discretion in selecting and approving videos.
- All riders using personal media players (iPods, mp3 players, iPads, tablets, laptops, etc.) are to use discretion when watching and/or listening to videos, movies and music.
- The bus will be divided into a guys and a girls section during non-daylight hours (front/back with adults in the middle).

#### **Showing Respect for Property**

- Each person will keep his/her seat and surrounding environment clean. Bus Captains can appoint special 'litter patrols' when needed.
- Damaging and defacing of property cannot and will not be tolerated. Individuals will be billed as necessary.

### **Showing Respect for the Law**

• No tobacco, alcohol, fireworks, illegal drugs or weapons.

• The bus ride is part of the CHIC experience and can provide a great opportunity to strengthen friendships, make new friends, share experiences with your youth group, and create life memories. We encourage all riders to engage in bus activities and therefore limit cell phone and personal media device time.
