132nd ANNUAL MEETING MINUTES

NORTHWEST CONFERENCE OF THE EVANGELICAL COVENANT CHURCH // APRIL 29-30, 2016 // LAKEVIEW COVENANT CHURCH, DULUTH, MN // "SERVE GLOBALLY"

Northwest Conference (NWC) Chairperson James Volling called the meeting to order at 2:32 pm. He welcomed everyone and announced the theme of the year as "Serve Globally." Jim talked about a concert that he and his wife attend every year, in which last year's theme was "Peace on Earth, Good Will to Men" and how this is lived out as we extend the gospel message around the world. Chairperson Volling then led in prayer.

MINUTES OF THE 2015 ANNUAL MEETING AT NEW BRIGHTON. MN

It was noted by Chairperson Volling that the Minutes from the 2015 Annual Meeting at Salem Covenant, in New Brighton, MN were approved by the NWC Executive Board, on behalf of the delegates. Further, Chairperson Volling stated the following Motion: That the Executive Board of the Northwest Conference, on behalf of the delegates to the 2016 Annual Meeting of the Northwest Conference, be authorized to approve the Minutes of the 2016 Annual Meeting at the next formal meeting of the NWC Executive Board. A second was made and motion approved.

AGENDA FOR 2016 MEETING APPROVED

Chairperson Volling added the addition of Marlys Wilson speaking for the NWC Women's Ministries. Motion to approve the agenda as amended was made and seconded. Motion carried.

HOST GREETING FROM LAKEVIEW COVENANT CHURCH

Pastor Brett Schmidt, Associate Pastor, greeted all attending, and spoke about spring here in Duluth. He spoke about the busyness in their church, from a new lead pastor, to a missions visit, to a funeral for a 3 month old where the father stood up to talk about God's faithfulness. Pastor Schmidt said that despite all of the differences in the pastors and congregations here represented, God's faithfulness is the same.

GREETINGS AND UPDATE FROM THE EVANGELICAL COVENANT CHURCH

Al Tizon, Executive Minister, Serve Globally, welcomed everyone on behalf of the ECC, shared that this is his first conference Annual meeting in his new role. He gave greetings from 120 missionaries who represent the ECC, and greetings from the president of the Democratic Republic of Congo who is here in the states for a month. Within Serve Globally, they see all of the five priorities within the ECC across all cultures and around the world. He also spoke about how the world isn't just over there anymore; the world is here.

SUPERINTENDENT'S REPORT

Mark R. Stromberg, Superintendent, expressed his thanks for Lakeview Covenant and the work that they've done to put this event together. He also recognized the delegates that came to the meetings and appreciates their dedication to take time off. Mark talked about his call to this ministry and this role and has been involved in so much of the ministry of the NWC. He talked about the impact of our local churches, camps and school, especially as we join together. Mark thanked the staff and pointed out the staff information to the delegates to read through and thank them. He asked the delegates to put the conference staff on their prayer lists. Mark pointed out the 3 ministry priorities- Congregational Vitality, Church Planting, and Children, Youth & Families in the NWC. Therefore, we are staffed according to our priorities. He spoke also about the mission and vision of the conference as well. He thanked the delegates for the wonderful things that their churches are doing. He reminded delegates that churches that are struggling are still making an impact and changing their world for Christ. Mark thanked the churches for their resources given to the NWC. Financial support is important, of course, but time volunteered is so valuable, for volunteers on the executive board. and some of the other key organizations within the NWC like the Ministerial Association. He encouraged delegates to go back and share with their congregations about the NWC ministry and challenge them to give faithfully to the NWC through time, talent & treasure.

Thanks Colleen Nelson and Tim Coyer for serving on the NWC Executive Board and for the three board members on the MA board who are finishing their terms on the board and are volunteering again for another set of years. He expressed his thankful for Dr. Donna Harris as president of MA. And for Christi Pease who was president of the Women's Ministries.

Covenant Community Bible Experience will be coming to the NWC. See www.covchurch.org/cbe. Look for information on this. He is also working on a 10 month cohort of pastors who will learn to evangelize and to equip their churches to evangelize. It is wonderful to build houses, serve soup, etc., but we need to be able to share what the hope is that we have in Christ. Mark finished by reading a poem Truth and Grace by Darrelyn Tutt. And John 1:14.

Rebecca Nguyen, NWC Secretary, stated that Compass

Covenant Church, St. Paul, MN and True Light Covenant

Church, Minneapolis, MN voted to close this past year. The

NWC Executive Board has acknowledged receipt of the

decision of each to close. Therefore, we are acknowledging
the closure of these two churches to be included in the official Minutes of the NWC 2016 Annual Meeting.

NWC MINISTRY DIRECTOR REPORTS

CONGREGATIONAL VITALITY: Jon Kramka, Director of Congregational Vitality, broke out his Vitality tie- he was given this as a gift from a church who appreciates the work that he does. Jon has had 5 years in this ministry area. "10 Healthy Missional Markers" have been developed. They contextualize these for local churches and are available at no charge for churches to use. The Vitality Pathway helps churches move forward. Personal renewal is emphasized as an important part of congregational renewal. Cord of three strands which show the ECC. NWC and local churches working together. Living Legacy churches have been affirmed and supported and the resources they have left are put in to planting new churches, as well as working with revitalization churches. We have seen the trajectory of churches closing flat line instead of increase as it has in the past. As we continue to press in on God's purposes and priorities, we know that we will continue on healthy paths. Jon pointed out his report in the Ministry Report

handout. Metrics are important in healthy churches. But let's look at some that are important as well. Are we building true meaningful relationships? Are we proclaiming the good news as truly being good news for today? Is there an increase in the number of leaders, mentors, missionaries, and teachers? Are we seeing an increase in the number of people being sent to start new ministries and churches? Are we raising up our kids to expand the ministries of the church? Finally, Jon encouraged everyone to be healthy missional leaders in their community and church in this shared pursuit.

CHURCH PLANTING: Mike Brown. Director of Church Planting, is excited about the fact that churches that are 20 years or newer make up 30% of the NWC churches. He continues to be excited about the commitment of the NWC to start 50 new churches by 2025. We're seeing more community based ministries, more people being reached by the local church. When you see in the news that the church is deaddon't believe it! The local church is growing and is healthy and is exciting. The big goal of 50 by 2025 is daunting, scary, exciting, expensive, wonderful, and hard. There are risks involved but the call is no less because every church planted, no matter how long its life span, has an impact! Church planting is normative, it's something that must be done. Denominations that don't have a church planting strategy are in decline. Also small churches are much more likely to plant more churches. In other words, you do not need to be a large church to participate in this venture. We've had churches become parent churches to new church plants, and we've had a district of churches all band together to support and plant a church in their region. Since our last annual meeting, we've had four new churches start. Since we've started this goal at our 2014 Annual meeting in Rochester, we've had eight new churches start. The four new fellowship groups and their pastors are:

- The Door Covenant Church, Pastor Jack Shields (Blaine, MN)
- Laotian Covenant Church, Pastor Vong Luangkhamdeng (Brooklyn Center, MN)
- Seeds Covenant Church, Pastor Dale Durie (SE Minneapolis, MN)
- The Story Covenant Church, Pastor Matt Anderson (Powderhorn, Minneapolis, MN)

It's looking like Pastor Dee McIntosh of Lighthouse Cov-

enant Church will be our next church plant, happening in July. Finally, Mike thanked the conference staff for the parts that they have had in keeping the church plants healthy, equipped, supported and thriving.

CHILDREN AND FAMILY MINISTRY: Kara Stromberg, Director of Children & Family Ministry, shared how she loves working with children because it reminds us that Jesus turned things upside down. He encouraged the children to come to him within a culture that taught children were not important. Sixteen churches have a full time person supporting children and family ministries. 88+ churches have only volunteers to run their children's ministry- they have to figure it out- but they love children and ministry. Kara has help from the Children & Family Commission. Networking, connections, and resource identification are priorities. We make sure that we have safety procedures in place to resource to churches. Are there larger churches who have well developed curriculum and resources and events that we can share with small churches? We help with transitions, making sure that new people are equipped, keyed in to other leaders and resourced for the ministry they will do. An upcoming event is "Go! Serve." It's for families with kids in elementary school to help families to both learn and serve together. There are still spots open. In the Twin Cities, there is a faithful group of people who meet to connect with other volunteers and staff in a connections group that meets monthly at Salem Covenant in New Brighton, Thanks for the honor to serve the next generation of leaders.

YOUTH MINISTRY: Ginny Olson, Director of Youth Ministry, spoke about Barna research polls that are not looking good, so it's no wonder that churches across the nation are indicating that youth ministry is a priority. Churches that see youth ministry as a priority have healthy groups, growing amount of youth learning about God and staying in the church. CHIC was last summer and we saw the impact of the NWC's priority of youth. We have MUUUCE for Jr. High students in the summer. We have MOVE- 22 ½ hours of serving the community, worship, sleeping in the gym, playing and learning about God. We wanted to show students that in a world of Instagram and snap chat, that they can impact their community in positive ways. We also support our volunteers and staff in youth ministry. There are monthly connection groups that meet to solve problems, support each other and the youth in our conference. Ginny shared that the best example she had of the tremendous youth people in our conference is from the Midwinter Conference. The youth pastors were asked to come and pray if they were struggling. One of our pastors went up for prayer. The rest of the pastors were encouraged to come up and pray for a pastor in their conference if they saw them needing prayer. When our youth pastor turned around, she saw 20 or more of our youth pastors standing behind her, supporting her with their presence and in prayer.

PASTORAL CARE & DEVELOPMENT: Jeff Burton. Director of Pastoral Care and Development, shared that this is his third year serving in this role. But it was in this very spot, as lead pastor, where he was commissioned to this role after being pastor at Lakeview for 7 years. There's never been such a critical time for pastors to have support in their roles. Church is more complex, pastor's roles are more complex and there is a need for support. Pastors have so few ways of measuring how they are doing in their ministry that they tend to gravitate towards numbers. Because even strong and involved members now attend on average 2 times a month vs. 4 times a month, pastors need to be equipped, educated, prayed for and supported by affinity groups as well. We have over 30 different chaplains serving in the NWC- they now have a group to get together and support each other. In addition, we knew that pastors needed support in the area of human sexuality. So Dr. Gary Strauss was hired to offer trainings to pastors in the last year. Also, four mini retreats in 2015 and two this year were held at camps. They were low cost, thanks to our camps, and were a chance to help pastors rest and be rejuvenated. We are also intent on giving resources to our local churches who ask how they can care for their pastor. We've had lots of conversations around Pastor Relations Committees, how much vacation do we give our pastor, and other questions that lay leaders have. As lay leaders, you ask, "What is the total cost of hiring/having a pastor?" But Jeff works with pastors asking, "What is the total cost of BEING a pastor?" There are financial considerations, but more importantly there are personal, emotional, mental and physical considerations. Jeff works with pastors through these questions and issues along with pastors in transition- retiring, out of a call, changing jobs. The Apostle Paul, in one of his letters, speaks about the physical pain that he's gone through, but at the end speaks about the weight of his daily concern for the church. This is a pain that we can't see on our pastors and Jeff helps them navigate this.

NWC MINISTERIAL ASSOCIATION

Reverend Herb Frost, Chair of the NWC Ministerial Association, was introduced by Jim Volling. Reverend Frost spoke about his thankfulness that Mark is a pastor to the pastors and of his thankfulness that Mark takes time to be a pastor and a leader. He thanked Mike for his leadership and laughter in his role as a church planter. The membership of the NWCMA is ordained clergy. He wanted to make sure it's clear that we are blessed that the board and staff of the NWC resource the NWCMA. He thanked the officers, who are volunteers. Herb also wanted to talk about pastoral pressures. These pressures include loneliness and isolation, cultural change and complexity, all work and no play, challenges of the job, neglect of lifelong learning, and working with staff pastors.

CHET NWC COORDINATOR

Greg Ellis, CHET NWC Coordinator, talked about how one of the fastest growing areas of the conference that does not speak English as a first language, is Spanish, CHET is based in Los Angeles. CHET NWC meets for 13 weeks every Monday night at MA (thanks for the generosity). The course is made up of six parts. It meets in six classrooms to study the life of Christ in their language. We are having our 3rd graduation coming up and everyone is invited to celebrate with these 12 students who have gone through all 6 parts. We are excited to begin to develop the opportunity to offer ministerial courses that CHET - LA has been offering. We'll be able to hear more about that next year. Greg's roles include making sure that the classes happen, that the teachers have resources and that everything is coordinated with CHET - LA. Please remember CHET NWC in your prayers, remember the pastors of the four Spanish speaking congregations in the NWC, and the teachers and mentors involved with CHET NWC.

PRESENTATION OF THE NORTHWEST CONFERENCE BUDGET

David Brown, NWC Treasurer and Sandy Norris, Director of Finance. David Brown introduced himself and thanked each church for the continued support of the NWC. Financial reports begin on page 14 of the Business Session Guide with our accountant's review report. We will highlight a couple of items and encourage you to review the reports over night. We will answer questions tomorrow before we vote.

Sandy Norris directed us to page 15 of the Business Session

Guide – the Balance Sheet. In business terms, the NWC has a value of \$1,646,244. We know that this is tangible and the NWC has great intangible value as well. Sandy walked us through the Statement of Activities. She used this as a means of sharing what we can watch for in our local churches. We have a new connections group for lay leaders and others who work with finances in the church. Find the next meeting on the NWC website. Dave highlighted the proposed budget on page 22 of the Business Session Guide.

PRESENTATION OF THE NORTHWEST CONFERENCE BALLOT

Rebecca Nguyen, NWC Secretary, presented the ballots as shown on pages 24 through 26 in the Business Session Guide, showing nominees for the NWC Executive Board (5 year terms) as Barb Dusek (Faith Covenant Church. Burnsville, MN) and Mark Hovestol (Roseville Covenant, Roseville, MN) as well as nominee for NWC Executive Board Chairperson, James Volling (Excelsior Covenant, Excelsior, MN) for a one year term. Nominees for the Minnehaha Academy Board of Trustees - new members, Erik Anderson (3 year term) (Crossroads Covenant, Woodbury, MN), and Keith Meyer (5 year term) (Hope Covenant, St. Cloud, MN). Returning Minnehaha Academy board members-John Ahlguist (2 year term) (Maple Grove Covenant, Maple Grove, MN), Tom Johnson (5 year term) (Roseville Covenant Church, Roseville, MN), and Kathy Parten (5 year term) (Bethlehem Covenant, Minneapolis, MN).

The NWC Executive Board previously made motion to accept nominees as stated, it was seconded and motion carried. The ballots were distributed to each delegate and the results to be presented the following day.

THE MISSION AND MINISTRY OF MINNEHAHA ACADEMY

Dr. Donna Harris, President, said that this is her 7th year of ministry at MA as president. She thanked the NWC for their support of the ministry of MA to students. She updated us on the STEM lab facility, some renovations that the school is working on, experiments to the International Space Station, and our work with Empty Bowls ministry. She talked about the accreditation process that they went through this year. Last year she talked about the donation that was given to enhance spiritual formation. There have been many programs, bible curriculums, spiritual ministry days for teachers/ faculty, chapel speakers and more because of

these funds. There will also be a spiritual formation assessment coming up. She highlighted the MA Cultural Field Experiences including experiences of students living with families in the Twin Cities for a week who are from a different culture. She thanked the NWC for their support. And then she introduced Dan Bowles, Director of Finance and Business Operations.

PRESENTATION OF MINNEHAHA ACADEMY BUDGET

Dan Bowles, Director of Finance and Business Operations, talked about the MA audit on page 10 in the Business Session Guide. It was a good audit. On page 12 on the bottom, he pointed out the total net assets. On the budget, he pointed out that they have budgeted for 806 students and asks for your prayers that there is a stabilization and increase in students. One of the big changes is the refinancing of MA's long term debt and has significantly reduced their interest payments. Our budgeted draw from reserves have been dropping, with the ultimate goal of the eliminating this completely. He ended by thanking the delegates for their support and their church's support and NWC's support in enabling students to attend MA.

SOLID ROCK SCHOOL OF DISCIPLESHIP AT LAKE BEAUTY BIBLE CAMP

Tyler Menssen, Director of Solid Rock, was introduced and shared about the program at Lake Beauty Bible Camp and the impact it has for students just out or recently out of high school where they can learn leadership, discipleship and hope in Jesus Christ and what they can do with their talents and gifts to share Christ's love. He shared his emailtyler@solidrockmn.org and the website is www.solidrockmn.org. He ended with a testimony from a student from the program. He asked for prayer for 20 students to come to Solid Rock.

NWC Chairperson James Volling gave a blessing for the supper and the rest of the evening. The meeting was adjourned at 5:34 pm until Saturday.

APRIL 13

COVENANT TRUST COMPANY

Steve Allison, Financial Services Representative, asked that we talk about what a Legacy has done in your church, consider a gift to a ministry, and share what you've done with others.

BALLOT RESULTS

Rebecca Nguyen, NWC Secretary, presented the ballot results stating that Barb Dusek and Mark Hovestol are elected to the NWC Executive Board for 5 year terms. James Volling was elected as NWC Chairperson for a one-year term. Erik Anderson, Keith Meyer, John Ahlquist, Tom Johnson, and Kathy Parten are elected to the MA Board of Trustees.

APPROVAL OF NORTHWEST CONFERENCE BUDGET

David Brown, NWC Treasurer and Sandy Norris, Director of Finance, were available for questions. The Motion previously made by the NWC Executive Board regarding the 2016-2017 Budget was seconded, and the Motion carried.

APPROVAL OF MINNEHAHA ACADEMY BUDGET

Dan Bowles, Director of Finance and Business Operations, was available for questions. The Motion previously forwarded by the MA Board of Trustees and made by the NWC Executive Board regarding the 2016-2017 Budget was seconded, and the Motion carried.

COVENANT ENABLING RESIDENCES

Dana Norton, Executive Director, CER-MN, shared that Covenant Enabling Residences of MN has two locations in Duluth and one in the Twin Cities, serving 24 adults. The NWC and Women's Ministries have been so instrumental in making sure that vulnerable adults who have developmental disabilities have a safe, nice home. Volunteers from Covenant churches give time, talent, and financial resources to help our residents in many ways. She thanked the churches for everything that they do to provide and care for their residents.

CAMPING MINISTRY IN THE NWC

Dave Cairns, Executive Director, Covenant Pines Ministries, stated that there are 5 camps in the NWC, more than any other regional conference. Many of our Ordinands shared that Bible Camp played a significant part in their call and life of faith. For many people, camp is that time of defining moments. He told a story about two weeks ago at the Father & Child retreat where a group of men came around a boy whose father had died the month before to be his "fathers" in this time of grief and need. He shared a story about how particular words came to him in a time of great need from what a pastor had said who spoke in 1990 at his first year as a counselor at Covenant Pines.

NWC WOMEN MINISTRIES

Marlys Wilson, President of NWC Women Ministries, shared the vision of the NWC Women Ministries. One of the projects they are working on right now, Missional Moms, is a book written by a Covenant woman. There is a free devotional that goes with the purchase of the book. In March there was a women's conference, Renewal, held at Redeemer Covenant in Brooklyn Park, MN. It was a two day event that 200 women attended. There was also an opportunity to come early and serve at a ministry. Marlys stated that they are looking forward to Triennial in Kansas City this summer. There is a bus coming from the NWC. There is also a training there for AVA (Advocates of Victims of Abuse). Additionally, because this is the 100th anniversary of Women's Ministries in the Covenant, they will be doing a lot to celebrate that milestone. It's also the

40th anniversary of women in vocational ministry. There will be two women from Sweden at Triennial, both who work with Middle Eastern refugees coming in to Sweden and they are available and willing to come visit and speak at your church. WM is looking for future locations for the Renewal conferences, and also looking for a new Executive Director for NWC Women's Ministries.


Good Shepherd Covenant Church, Blaine, MN

Good Shepherd began in 1962 with a handful of faithful Christ-followers sensing God's call to plant a Covenant church in the northern suburbs. Over the years, the church impacted the Blaine, Coon Rapids and Ham Lake areas.

In its latter years, Good Shepherd served as a Manna Market distribution site; a food recovery and redistribution ministry that served 538 households in 2016 alone.
