

DEAR MINISTRY COLLEAGUES,

"I thank my God every time I remember you. In all my prayers for all of you, I always pray with joy because of your partnership in the gospel from the first day until now, being confident of this, that he who began a good work in you will carry it on to completion until the day of Christ Jesus." – Philippians 1:3-6

Paul writes this letter to the church in Philippi while under arrest and under very difficult circumstances-yet the word joy appears in this very short letter more than a dozen times as do other words like hope and expectation that at first glance seem to defy the circumstances. Yet that is what Jesus did then and continues to do for his children even today.

Many of us are coming out of experiences not as dire as Paul's but certainly spaces of challenge and it's my prayer that the hope and joy we have that is rooted in Jesus would pervade even the most arduous places in our lives and ministries. You are not laboring in vain as Philippians 2:16 reminds, and I pray that joy and hope Paul experiences in our text would not only fill you but be seen in your cities, towns, churches and contexts—and bring people one step closer to a God who can give hope and joy to us all, even in their most dire of circumstances.

This letter serves as a joyful invitation, and as a prayer, as we gather this year at Bemidji Covenant Church from April 27-28, for our Ministerial Association Annual Meeting. It will be a hopeful space to encourage one another and aid us all to move forward in our ministries for God's glory and our neighbor's good.

FRIDAY EVENING OFFERING

The Friday evening offering is designated for the Bemidji Community Food Shelf (bcfsmn.org).

2022 marked 40 years of service to Bemidji and surrounding communities. The food shelf started as a small store front in downtown Bemidji with a few dedicated volunteers and has grown to include a mobile truck and a farm. The farm provides high-quality fresh produce as well as an opportunity for community members to contribute their time and talents.

During 2022, 9,600 families, consisting of 28,000 people received almost 600,000 pounds of food. Nearly 10,000 of the recipients were children (a 40 percent increase over 2021) and 6,000 were seniors-the fastest growing segment of food insecure in the State of Minnesota.

Jim Fretheim, former NWC Superintendent, is on the Board of Directors and is grateful for this ministry that serves his neighbors in need.
